V. TERMS OF THE AGREEMENT

The details of this contract reflect our concern that both the new owner and adopted animal have a happy life together. We feel that we have a continuing commitment to see that our rescued animals find a safe and happy permanent home and prevent the animal ever again being in a position to return to a shelter / rescue.

For and in consideration of the receipt of the above-described animal, I, the above-named Adopter, agree to the following list of terms:

1. This animal is a companion animal and is not being adopted for slaughter, factory farming or to be resold for a minimum of one year commencing after the trial period. **** see #4 for conditions****
2. Animal is to go with the Adopter for a 2-month trial period. At the end of the 2 month period, if the adoption is not suitable, SCCR (Second Chance Cheekye Ranch) will take the animal back and will provide the full adoption fee refund minus an admin fee of \$250.00. The animal should be in good health or refund may be waived. Adopter is responsible to pay for return hauling to CHEEKYE RANCH in Squamish, BC. **** Please allow adequate time for the animal to adjust to its new surroundings as moving to a new home can be very stressful and they can take some time to settle in.**
3. To love and provide adequate shelter, veterinary care, farrier care and humane treatment at all times for the animal in order to maintain a healthy body condition. SCCR (Second Chance Cheekye Ranch) shall be listed as an alternative contact on any boarding, vet care or other contract regarding the animal.
4. To keep said animal as my own personal property at all times. Not to sell, barter/trade, loan, give away, transfer ownership, abandon, or dispose of said animal in any way without written permission of SCCR (Second Chance Cheekye Ranch) SCCR has the First Right of Refusal and would appreciate notification and contact information of a new owner if SCCR waives it's right to purchase the animal back.
5. Adopter agrees to keep a current address on file at SCCR (Second Chance Cheekye Ranch) and will notify SCCR (Second Chance Cheekye Ranch) immediately of any permanent location change of said animal.
6. This animal is not to be bred. Breeding will be considered a breach of this contract and SCCR (Second Chance Cheekye Ranch) and its representatives shall retain the right to determine if such breeding nullifies the contract. If this contract is considered null and void, SCCR (Second Chance Cheekye Ranch) may peacefully enter onto the premises and into the facilities where the said animal is being kept and retake possession of the said animal. If I adopt a male animal that is too young to geld, said animal shall not be allowed any contact with female animals prior to being gelded. I further agree that said animal shall be gelded no later than 6 months to 1 year after adoption. I agree to have a licensed veterinarian perform the necessary surgical procedure.
7. If the animal is no longer wanted, or can no longer be kept, the adopter shall notify SCCR (Second Chance Cheekye Ranch) immediately and the animal shall be returned to SCCR (Second Chance Cheekye Ranch) at the adopter's expense.
8. Except under extreme circumstances, if said animal is sick or injured, I will not have said animal euthanized without first consulting with SCCR even if I can not afford to have it treated.

To notify SCCR (Second Chance Cheekye Ranch) within 48 hours of death, loss or movement of said animal.

9. To allow an SCCR (Second Chance Cheekye Ranch) representative to examine the said animal and its living conditions without receiving prior notice of any visit.
10. If at any time this animal is found to be in unsatisfactory condition, or SCCR (Second Chance Cheekye Ranch) determines that it is not being properly cared for, SCCR or any of its representatives may peaceably enter any property on which the animal is kept and reclaim it immediately with no refund of adoption fees.
11. Adopter agrees to send updates (including photos) on the animal at minimum of every 6 months or when SCCR (Second Chance Cheekye Ranch) requests it.
12. I hereby give SCCR (Second Chance Cheekye Ranch) permission to share photos taken by them or provided by myself as well as my first name, city where the horse is located, and other relevant information, on their website, Face Book and other public places they deem appropriate regarding placement of the animal I'm adopting.
13. Upon signing this agreement, I agree to pay in full the monetary adoption fee in the amount of \$ _____. The Adoption fee will be non-refundable,
14. If the animal is to remain at SCCR (Second Chance Cheekye Ranch) for 5 or more consecutive days between the decision to adopt and the pick-up date, a \$100.00 non-refundable deposit is required. This will be taken off of the adoption fee and will not be returned if the adopter changes their mind before pick-up. Should the animal remain at Cheekye Ranch for more than the 5 days, board will be charged on a daily and or weekly rate until transport. (Check with Cheekye Ranch for rates)
15. Although all information that SCCR (Second Chance Cheekye Ranch) has on said animal is released to the Adopter, I do understand that SCCR (Second Chance Cheekye Ranch) is a rescue service and is in no way responsible for the accuracy of information received about temperament, habits or physical condition of the said animal that I am adopting. Adopter agrees to indemnify, defend and hold harmless SCCR (Second Chance Cheekye Ranch), its volunteers and members from any liability resulting from this adoption.
16. To obey any and all animal control regulations governing the area in which I live. Failure to obey any state or local law regarding animal control and/or welfare shall be deemed a breach of this contract, and this contract will be considered null and void.
17. In the event that SCCR (Second Chance Cheekye Ranch) determines that I am in breach of this contract, this contract will be considered null and void and SCCR (Second Chance Cheekye Ranch) may peacefully enter onto the premises and into the facilities where the said animal is being kept, and retake possession of the said animal.
18. I understand that if this contract is rendered null and void by my breach of any term of this contract, I will not be entitled to any reimbursement of any funds whatsoever. I also agree to pay all costs associated with my breach including, but not limited to, vet or farrier costs resulting from neglect/abuse of the animal while in my care and transportation costs.
19. I agree to pay any and all reasonable attorney's fees and all court costs of SCCR (Second Chance Cheekye Ranch), in the event that any matter arising under this contract is forwarded to any attorney for enforcement of SCCR (Second Chance Cheekye Ranch)'s rights and remedies under this signed contract.

20. I understand that this contract is entered into in the Province of British Columbia and will be interpreted and enforced under the laws of this Province even if the animal lives in another Province.
21. Upon the signing of this contract, I acknowledge that I have read, understand and agree to be bound to SCCR (Second Chance Cheekye Ranch)'s contract. I understand that if any of these terms have been failed to be adhered to or are breached, the contract will be considered null and void and SCCR (Second Chance Cheekye Ranch) may peacefully enter onto the premises and into the facilities where the said animal is being kept, and retake possession of said animal.
